INSCRIPTION CONDITIONS

GLOSSARY

- 1.1. In the convention of inscription, the following terminology is used:
 (a) Administrative charge Refers to the cost incurred by the institution in the processing of some procedure for the student (inscription, change of course, cancelation, etc.)
- (b) Starting date Refers to the day when the course begins which is indicated on the corresponding brochure.
- (c) Course or Program Refers to the structure of the clases in which the student is enrolling.
- (d) Admission fee (Inscription rate) Refers to the quantity of money payed by the student in order to book a place in one of the courses or programs offered by the school.
- (e) Modules Refers to the evaluation periods within a course or academic cycle. For the full-time courses, the evaluation period is one trimester and for those of half-time it is one semester.
- (f) Candidate or Student Refers to the signer of these terms and conditions.
- (g) Studio Refers to the studios and practice workstations available within the enclosure of the school-

2. **FEES**

- 2.1. The student undertakes to pay the total sum of enrollment fee so that the booking of a place in the chosen course could be valid.
- 2.2. The inscription rates should be payed at least one month before the begining of the course. The students who violate this premise won't be able to enroll in the course and their place will be offered to another candidate. This condition is aplicable no mather the payment method elected.
- 2.3. In case that a student notifies the school, in writing, that he won't start a course WITHIN A PERIOD OF NOT MORE THAN FOURTEEN (14) DAYS after submitting the inscription form and paying the coresponding quota, the payed amount will be repayed except for £100,00, for administrative charge. No repayment will be done in the period of less than fourteen days after submitting the inscription form nor after the course begins.
- $2.\dot{4}$. The credit for fees paid and not used won't in any case be transferred to other person.
- 2.5. The student accepts the right of admission reserved by the school. Decisions of this kind are under the jurisdiction of the School manager and/or Coordinator of the course in which the student is enrolling.

3. SYLLABUS AND CLASS SCHEDULES

- 3.1. The student accepts the right the school has to change the content of the course in whish he is inscribed, without previous notice, that way updating the outdated or inapropriate topics, eliminating them and introducing new topics.
- 3.2. The student accepts that the school can vary the days and/or class schedules.

3. CANCELATION AND POSTPONEMENT

- 3.1. Postponements or cancelations by the student should be reported in writing to the school administration, using for that purpose the coresponding form. Not assisting the lectures or communicating the intention verbaly cannot in any case replace the written notification.
- 3.2. If a student decides to postpone, cancel or end the course, he should pay the cancelation fee in the moment that the school is notified of such decision in writing. This fee will be equivalent to two monthly payments for the program in which he is enrolled.
- 3.3. To those student who had already payed the total rate of the course, the school will repay the fees for the non-attended modules, except for the cancelation fee. The modules attended completely or partially will not be repayed.
- 3.4. In any case, the date of cancelation will be determined by the date of reception of the cancelation form by the school. All of the due course fees until that date should be payed.
- 3.5. If a student whishes to withdraw his inscription, he should notify the school about it in writing BEFORE the begining of the chosen course. In this case, the payed course fee will be repayed, except for &100,00 for the administrative fees. The Inscription rate will be repayed according to the terms specified in the subparagraph 2.3 of this document. Once initiated the course, the conditions of cancelation shall be governed according to the terms specified in the subparagraphs 3.2 to 3.4.
- 3.6. The cancelation or postponement will remain in force for two years. Once expired this date, the possibility to regain the cancelation fee will be lost.

4. CANCELATION BY THE SFGS

- 4.1. SFGS could cancel the registration or impede access to class to that student who doesn't fulfill his obligations, or whose behavior disturbs the normal conducting of the clases or practical activities. In any case, the fees and charges for the course until the moment of expulsion should be fully payed by the student. The conditions mentioned in the subparagraphs 3.2 to 3.4 will be used to calculate these charges.
- 4.2. SFGS preserves the right to cancel a course/class until the starting date in case that there is not sufficient students enrolled in the course/class. In this case, the inscription fee and the payed rates will be fully repayed.

5 INFORMATION ABOUT THE SCHOOL

- 8.1. The student, also, accepts to have read and understood all the conditions described in this contract.
- 8.2. Any information from this brochure that results unclear to the student should be consulted with the administration of the school BEFORE formalizing the registration. Signing this contract implies the acceptance of all the specified conditions. All of the data is correct, except typographical errors.
